Background

The audit has been developed and approved by BAOMS Clinical Effectiveness Committee. There are 3 data collection points:

- Pre-treatment (patient and surgeon)
- Operation notes (surgeon)
- 3 month follow-up (telephone call to patient)

Ideally, you should aim to collect data on all patients presenting with 3rd molar problems over a 3-month period.

Data collection

Data forms - version control

Old versions of the forms on BAOMS website asked for "Assessing Surgeon's" name and GDC or GMC numbers. Updated versions require details of the "Consultant in Charge". Please amend your records to reflect this change.

Health and Social Information Centre (HSCIC) Clinical Audit Platform

Please register your site, surgeons and data entry staff using the <u>N3MA User Registration form V1.2</u>

- To enter or upload data using the HSCIC Clinical Audit Platform you must register first
- Registered surgeons can get all their own data back immediately
- NHS or CHI numbers are required fields.
- Surgeon GDC or GMC numbers link surgeons to their patients and are required fields
- Data can be linked to Hospital Episode Statistics etc.







Optional Excel data entry form - advantages

- No Internet connection is required.
- Data is automatically formatted for uploading to HSCIC
- You can add your own data fields to the N3MA audit data. Call NFORC for advice.

3 month follow-up

Once you have entered a treatment date, the Excel dashboard and HSCIC N3MA interface will provide you with a report that lists patients who require a follow-up phone call.

Document Management

It is good practice to maintain an Audit Master File containing relevant documents and copies of all consent forms.

Obtaining consent

This is a consented audit. See N3MA Information and Consent for patients V3 (WORD) or (PDF)

Check that the patient initials the boxes adjacent to the questions on the consent form and prints and signs their name, writing the date in the appropriate place. The consent form should be countersigned and dated by the person taking consent.

Make 2 copies of the signed information and consent:

- Give 1 to the patient
- Put 1 in the notes
- Keep the original in your Audit Master File

Before you start

Consider informing your Clinical Audit department that you are undertaking a BAOMS badged audit. This may be compulsory in some trusts. If you need to fill in a form, the "Information for Surgeons" document above contains relevant information including audit background and aims.
