Rule 3 : Tax

- Pension tax is complicated
- Pension tax is not logical
- Pension tax is unfair
- Pension tax bill is retrospective
- You might avoid a pension tax bill with 3 years notice

NHS pension

Look at TRS: how much pension? When can you access it?

Check service duration

Added years in 1995: Still needed? Calculate uplift

Request (free) pension saving statement every year

State pension:

Check what you have accumulated so far

When can you receive it? Can you pay to fill in gaps?

Private pension and investments

Do you have paperwork for all policies, Value so far?

When can you access the money in most tax efficient way?

Can your pension help you now?

The NHS pension can be accessed if you retire through ill health.

Could this replace an income protection insurance policy?

The Doctor's Pension MOT

Tax on pensions

Calculate how much annual allowance you have used every year

Calculate how close you are to the Lifetime Allowance

Planning future tax and savings

Will changes in income in the next 2 or 3 years lead to a pension tax charge?

What can you do to prepare for that event?

Can I save for retirement any other way (eg ISA)

The bottom line.....retirement readiness

How much income do I need in retirement.

How much have I got so far
