UPDATES FROM THE BAOMS QOMS PROJECT SINCE MAY 2022



QOMS PROGRESS

Sixteen hospitals in England, Wales and Scotland have contributed or are contributing to the various registries in QOMS.

Remember that participation is open to every OMFS department in the country, regardless of size and you don't have to contribute to all the registries.

Data collection is going well, and we are approaching the 4000 patient records mark in REDCap. This would not be possible without all the data coordinators and surgeons participating to the project. Thank you all.

At the time of writing this newsletter, we have just over 450 and 223 records in the two Oral and Dentoalveolar surgery registries, 951 in Trauma, 1051 in Oncology & Reconstruction and 217 in Orthognathic surgery. At the beginning the summer, we finished the second snapshot for Non-melanoma skin cancers (NMSC), 550 were collected. So far we have collected >1000 cases of for that subspecialty. The third cycle for NMSC started on October 3rd, 2022 until November 30th, 2022.

Following our last Newsletter in May, we have released live

dashboards in REDCap for the current QOMS audits. They are a work in progress and any suggestions to improve their content are welcome. The links to view the global (aggregated) dashboard are available to BAOMS members only on the BAOMS website. Click here.

Work is underway to analyse the data collected so far by the teams across the country. We plan to produce and release our 1st QOMS Report by the end of 2022 or early 2023. This represents a major landmark in the OMFS, BAOMS and the QOMS project, it is anticipated that each subspecialty within the project will be well represented and discussions are in place for the inclusion of a section on TMJ surgery.

Prior to this year's BAOMS ASM in London, QOMS had organised a 2nd QOMS summit where we had invited speakers from established national quality improvement projects/registries and audit initiatives, with proven track records. Despite the (nice) weather and the transport strikes, 20 people joined in person or on line to listen to Marisa Mason (NCEPOD), Sam Waton (NVR), Sheena McSween (CholeQuIC), Antoinette Edwards (TARN) and Ramani Moonesinghe (PQIP). They shared their experience of data collection. It was really reassuring to hear that we are not alone and that we are doing things right! Thank you everyone! The recurring theme from each of these projects was that their success, relied heavily on engagement and initiatives of the collective members of the involved specialties at all levels, the initial several years of the project involved a considerable amount of effort in laying the foundation before the visible

output becomes evident after a period of time lag, and that all of these initiatives were much better resourced than BAOMS QOMS, accepting that we are a smaller specialty.

The BAOMS QOMS annual update was presented to the membership within the BAOMS AGM. This was well received by the council and membership, with recognition of the importance of the initiative to OMFS and BAOMS going forward. BAOMS QOMS early data/results were presented to the delegates in the 'Outcomes' session in conjunction with presentations from NCIP and TARN. This generated a considerable amount of discussion amongst the delegates. In addition of the main auditorium sessions, BAOMS QOMS was linked to several oral abstract and poster presentations, providing additional visibility and increasing awareness of the project across all levels of the specialty. Overall, the 2022 BAOMS ASM in London, was a constructive and welcome avenue for BAOMS OOMS to interact with BAOMS members and efforts are in place to ensure that this becomes a regular feature in the future.

The QOMS team hold online meetings every 6 weeks generally. See the new schedule for 2022/23 is provided in the table opposite.Contact Fabien if you are interested in attending any of the QOMS Team meetings.
